As you complete your application, please keep in mind the following ASAM Admissions policies:

Scholarship applicants to ASAM programs are expected to adhere to the schools principles around equality, integrity, honesty and the pursuit of excellence in all academic activities both in the classroom and beyond. ASAM expects that your application for scholarship funding reflects your intention to commit fully to the requirements of the Accelerated Management Performance Program.

ASAM expects that the endorsement of the applicant's candidacy for scholarship funded entry to the Accelerated Leadership Performance Program from the applicants Direct Manager (or alternative representative of employer) confirms:

- The intention of the organisation to support the applicant throughout the program.
- The organisations endorsement of the applicant's worthiness and commitment to participating in the Accelerated Leadership Performance Program.
- Should the application for scholarship funding be approved, the organisations intention to fund the balance program fee unless it is the prospective students intention to self-fund the balance payment.

ASAM reserves the right to verify all information and recommendations contained within your application.

ASAM further reserves the right to rescind an offer of admission or terminate a student's enrolment should it discover that any misrepresentation or omission occurred in the application process or if it learns that you have engaged in behaviour prior to program entry that indicates a lack of judgment or integrity. In some cases, ASAM may require an applicant to provide additional verification of the information and documents submitted as part of the application.

Evidence of prior academic achievement is not a stipulated requirement of the application for scholarship funded entry to the Accelerated Leadership Performance Program.

In some instances, the National Scholarship Committee may request that an Admissions Officer make contact with an applicant to seek clarification around the commitment of the applicant and/or the applicant's organisation to participation in the Accelerated Leadership Performance Program.

ABOUT THE NATIONAL INDUSTRY SCHOLARSHIP PROGRAM

The National Industry Scholarship Program initiative is the result of the Australian School of Applied Management and Women & Leadership Australia's commitment to supporting the advancement of women into positions of leadership across the Australian workforce. By periodically focusing on specific industries, the initiative distributes financial support for the development of women managers across all sectors.

The National Industry Scholarship Program includes a commitment to provide financial assistance to at least 15% of Accelerated Leadership Performance Program participants across all sectors nationally.

FINANCIAL SUPPORT

The standard enrolment fee for the Accelerated Leadership Performance Program is \$8,490. Scholarship recipients are awarded a subsidy of \$4,500 which reduces the program fee to \$3,990.

INSTALMENT PAYMENTS

In keeping with the spirit of the National Industry Scholarship Program, the balance program fee of \$3,990 can be made via the Instalment Fee Payment Plan.
